3. You agree that we shall send your Statements* by electronic mail until we receive your instruction to revoke the request in **writing**. The Statements* shall thereon be delivered to you by way of ordinary mail on the next working day after the receipt of the instructions to revoke from you.
4. You consent and agree to receive the Statements* through ordinary mail or by fax in the event of system failure or any reasonably contemplated circumstances associated with electronic mailing mode.
5. You are aware of the inherent risks associated with the delivery of electronic mail. As such, you agree to accept and assume, at all material times, the inherent risks that is associated with delivery of the Statements* and will not hold TAF liable or responsible for any loss, damage, expense, liability, cost and claim whatsoever and howsoever arising thereof.

This is to ensure that the Statements* will not be delivered to the wrong party.
