

INTERIM AGREEMENT FOR INTERNET TRADING FACILITY

(CORPORATE CLIENT)

In consideration of TA Futures Sdn Bhd ("TA Futures") extending to me / us the TA FUTURES Online service or such other online trading services as may be renamed or replaced thereby (hereinafter referred to as "Service"), I/we hereby acknowledge that this is an interim agreement and I/we agree to execute the Complete Online Agreement and such other documents when it is presented to me/us in due time.

1. I/We declare that I/we have knowledge of an internet trading facility and the process of entering Direct Market Access order;
2. I/We declare that I/we have knowledge of the requirements in the Rules, Directives and Trading Procedures in relation to trading on Bursa Malaysia Derivatives Berhad ("BMDB");
3. I/We declare that I/we have knowledge of the relevant laws pertaining to trading on Bursa Malaysia Derivatives Berhad ("BMDB").
4. I/We declare that the particulars and information given in this Interim Agreement are true and correct and I/we have not withheld any material facts or information from you.
5. I/We acknowledge that the usage of the Service will be at entirely at our own risk. TA Futures shall not be liable for any loss, damage, delay or other result caused by any failure, delay, fault, downtime, crash, breakdown, malfunction, defects, bugs, glitches, loss of access in the Service or any errors in the transmission of orders through the Service.
6. I/We hereby agree that TA Futures may from time to time and at its absolute discretion vary the terms and conditions of the Service and charges.
7. I/We understand and agree that all charges incurred by me/us in using the Service shall be borne by me/us and I/we hereby authorize TA Futures to debit the relevant charges to my/our account maintained with the Company.
8. I/We agree that TA Futures reserves the right to reject, withdraw or terminate forthwith without notice my/our application or usage of the Service without assigning reasons thereto and under no circumstances shall TA Futures be liable for any loss or damage for such action.

For the avoidance of doubt, BMDB and /or BMB shall not be liable for any losses or damages caused as a result of any inability to trade or curtailment of any trading opportunities howsoever arising, including, but not limited to, the failure, malfunction and /or breakdown of the OMS Services.
