- 1) I and the Designated Representative(s) have knowledge of an internet trading facility and the process of entering Direct Market Access orders.
- 2) I and the Designated Representative(s) have knowledge of the requirements in the Rules, Directives and Trading Procedures in relation to trading on Bursa Malaysia Derivatives Berhad ("BMDB") and knowledge of the relevant laws pertaining to trading on Bursa Malaysia Derivatives Berhad ("BMDB").
- 3) I shall not make any claims against you for all and any matters relating to this Authorisation.
- 4) I declare that you shall not be held liable or responsible to me for any loss or damage however and whatsoever arising as a result of any act, neglect, omission or negligence of the Designated Representative(s) or any of them in their execution of their powers under this Authorisation.
- 5) I shall at all times fully and effectively indemnify you and keep you fully and effectively indemnified against all actions, suits, proceedings, claims, demands, losses, charges, penalties, fees, fines, costs and expenses whatsoever made, taken, brought, instituted, imposed, suffered, incurred, prosecuted or payable in any way howsoever (including without limitation negligence, innocent or fraudulent, on your part or on the part of your agents, employees or servants) against or by you to any person arising out of or incidental to this Authorisation.

- 6) I declare that this Authorisation being given for valuable consideration shall be valid until written revocation is given by me to you duly acknowledged by you or any of your right to future performance of such provisions and my obligation in respect of such future performance shall continue in full force and effect
- 7) Failure or delay on your part to insist in any one or more instance(s) upon the performance of any provisions of this Authorization shall not be construed as a waiver or relinquishment of any of your right to future performance of such provisions and my obligation in respect of such performance shall continue in full force and effect.
